What are cookies?

Cookies are small pieces of text stored on your computer when you visit a website.

They are not programs and cannot be executed as code or deliver viruses - instead cookies act more like a passport, which the site checks and updates whenever you visit.

Almost every site on the internet uses cookies and their functions include:

- verifying your identity for security purposes
- determining the type of browser and settings you are using
- allowing site owners and third-party advertisers to tailor content to your preferences

Our policy

We respect your privacy and are committed to providing you with the information and tools you need to manage your cookies.

There are three types of cookies on this site:

Essential cookies are necessary for the vital functions of our site and trading platform. If these are disabled, you won't be able to access the platform or other important parts of the site.

Behavioral and analytical cookies help us provide you with a better service. They can tailor site content to your personal preferences and past behavior or remember your saved settings.

Marketing cookies enable you to experience more relevant online content and see adverts which are aligned with your interests, as indicated by your activity on our site.

Essential cookies

Some parts of our website, particularly our trading platform, require these essential cookies in order to function.

If they are disabled, you will be unable to use our trading platform and some areas of our website won't function correctly.
